

BAA/BABAA GUIDANCE

Comprehensive Guidance on BAA & BABA Compliance

1. Identifying the Applicable Funding Agency

- Use Bright Future USA's Compliance Checklist to identify whether your project falls under the Buy American Act (BAA) or the Build America, Buy America (BABA) provisions. This depends on how the project is funded and which agency is providing the support.
- The funding agency determines which rules apply. For example, if the project is funded by the Federal Transit Administration (FTA), BABA rules may apply; if funded by a different agency, BAA or another set of federal procurement guidelines could be in effect.

2. Guaranteeing BABA Compliance

- Bright Future USA guarantees that manufactured products meet or exceed BAA/BABA's domestic content thresholds, including those relating to steel, iron, and manufactured products.
- All bills of materials are reviewed in accordance with guidance from the Made in America Office, reinforcing our commitment to domestic sourcing.

3. BAA-Compliant U.S. Manufacturing

- Bright Future USA's BAA & BABA-compliant products are manufactured in the United States, fulfilling federal procurement standards.
- Contractors working with foreign-sourced materials can apply for a non-availability waiver as part of the federal compliance process.

4. Transparency in Procurement Decisions

- We provide detailed compliance documentation, including certifications, bills of material (BOM), and supporting records, helping project teams align with federal procurement policies.
